MINOR SUBDIVISION REVIEW SUBMISSION REQUIREMENTS

In order to expedite the review of Minor Subdivision applications, please be sure that all of the following items have been included in your Subdivision application. <u>Please return this completed checklist with the application to assure that all items have been addressed</u>. All Minor Subdivision applications must adhere to the regulations found in the Town of Urbanna Zoning Ordinance.

Minor Subdivision application fee of \$100 per lot created. A minimum of three (3) copies of the subdivision plat. The plat must provide the following information: a. The name of the subdivision, preparer of plat and owner of record. b. The date of the drawing, scale and north point. c. An insert map showing the location of the subdivision with reference to existing streets, watercourses and other landmarks. d. The layout, boundaries, area and frontage of the parcel or tract to be subdivided. e. The layout, boundaries, area and frontage of new lots to be created. f. The location of existing and proposed streets. All proposed streets must meet the following requirements: • All proposed public streets must be designed in accordance with the Virginia Department of Transportation's <u>Subdivision Street Requirements</u> , January 1, 1996, as may be amended. g. The location of all Chesapeake Bay Preservation Act features, including the Resource Protection Area (RPA) and Resource Management Area (RMA). h.
