*Allowed reasons for electronic participation per § 2.2-3708.3 of the Code of Virginia:

- 2. The Councilmember must provide care to a family member due to a medical condition or to a person with a disability at the time the public meeting is being held thereby preventing their physical attendance.
- 3. The Councilmember's principal residence is more than 60 miles from the meeting location identified in the required notice for such meeting.
- 4. The Councilmember is unable to attend the meeting due to a personal matter and identifies with specificity the nature of the personal matter. (This reason cannot be used more than six times per year.)

If participation is approved, the minutes must state the remote location from which the member participated; however, the remote location need not be open to the public and may be identified in the minutes by a general description.

6a. Ordinance 002-2025: Establish FY25/26 Bi-Monthly Residential and Commercial Water Rates

Background: Like much of the country's infrastructure, Urbanna's water system continues to age and require maintenance, repair, and upgrade. A 2021 water system study estimated the cost of these actions to be approximately seven million dollars (\$7,000,000). No doubt today, that figure is higher.

Funding sought by the town has been denied and two reasons cited: 1) low in-town rates, and 2) the disparity between in-town and out-of-town rates. Funding entities want to see a commitment to the improvement via a willingness to do what is necessary, such as rate increases, to cover loan amounts or provide matching funds. Urbanna is out of the customary variance range between in-town and out-of-town rates and has the lowest rates overall in the area. This increase would help to decrease the variance range and show lenders the town's commitment to maintaining and improving the water system. Incremental increases have been deemed more manageable for users than one large increase.

The FY25-26 Town Budget factored this increase into the revenue and expense projections for the Water Fund.

Fiscal Impact: The increase to the in-town base charge will result in 10% increased revenue. The increase to the out-of-town base charge will result in 5% of increased revenue.

Staff Recommendation: Adopt as presented.

Background: Historically, the VFD, VRS, and Library have been exempt from paying water usage fees to the Town. However, documentation stipulating these exemptions could not be found in Town records. The Finance Committee and Water Committee have both met to discuss these exemptions and agree that the Town should continue to offer the exemptions. It is also agreed that formal Council action should occur to solidify the exemptions and create a historical record for the future. This exemption does not include any sewer or sewerage fees.

Fiscal Impact: Because these organizations have historically been exempted as far back as can be traced, there is no fiscal impact. However, based on an analysis of usage data, it was determined that none of the entities use more than the minimum thus the average annual water usage costs for each is \$328.26. Collectively, the annual water usage costs total \$984.78.

Staff Recommendation: Approve each resolution presented to solidify the water usage fee exemptions for each organization.

Council Action Requested: Yes.
