The street closures are enumerated in the master plan as well as in the attached resolution.

RESOLUTION 2025-016 STREET CLOSURES AND TRAFFIC RESTRICTIONS DURING THE 2025 URBANNA OYSTER FESTIVAL

WHEREAS the Town of Urbanna, Virginia, will host the annual Urbanna Oyster Festival
 on Friday, November 7, 2025, and Saturday, November 8, 2025; and

- **WHEREAS** the Urbanna Oyster Festival, organized by the Oyster Festival Foundation, is celebrating its 68th year, marking a significant tradition and cultural event within the community; and
- WHEREAS the street closures and traffic restrictions necessary to ensure public safety
 and the orderly conduct of the festival are detailed in the 2025 Oyster Festival Master Plan and
 Public Safety Plan; and
 - **WHEREAS** the safety and security of the public, including festival attendees, residents, and participants, necessitate the closure of certain streets and the restriction of vehicular traffic within the town limits; and
 - **WHEREAS** it is the responsibility of the Town of Urbanna to take necessary actions to ensure the orderly and safe conduct of the festival; and
- WHEREAS public safety officials have determined that certain streets and locations
 must be closed to vehicular traffic at specified times to facilitate the festival and the Fireman's
 Parade;
- NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Urbanna, Virginia as follows:
- 1. Street Closures on Friday, November 7, 2025:

- Virginia Street from Cross Street to the waterfront and from Cross Street to Grace
 Street; Rappahannock Avenue from Marston Avenue to Virginia Street; and a portion of Prince George Street shall be closed to vehicular traffic as required by public safety officials.
- Notwithstanding the foregoing, various streets and locations may be closed at any time on Friday, November 7, 2025, to ensure public and/or pedestrian safety as determined by public safety officials.
- 2. Traffic Restrictions During Fireman's Parade on Friday, November 7, 2025:
 - Vehicular traffic entering or leaving the town shall be prohibited on the West side (Route 602) from 5:00 PM to 9:00 PM and on the East side (Rosegill) from 6:00 PM to 9:00 PM.
 - During this time, the movement of vehicular traffic within the town shall be limited,
 and vehicular traffic, except for parade participants, shall be strictly prohibited along
 the Fireman's Parade route.
- 3. Street Closures on Saturday, November 8, 2025:

- At 9:00 AM, or earlier if deemed necessary by State Police, State Route 227 (Urbanna Road) shall be closed to all vehicular traffic except law enforcement, and fire and rescue vehicles, with a police-manned barricade at Molly's Way. Vehicles will be directed to park in the "official" festival parking lots or will be allowed to turn around and leave the area.
- At 9:00 AM, or earlier if deemed necessary by State Police, State Route 602 (Old Virginia Street) shall be closed to all vehicular traffic except law enforcement and fire and rescue vehicles, with a police-manned barricade at Route 1011 (Red Hill

Drive). Only vehicles displaying an "Official 2025 Urbanna Oyster Festival" vehicle
permit, issued by the Urbanna Oyster Festival Foundation, shall be permitted further
entrance past the police barricade. Vehicles without a permit will be directed to park
in the "official" festival parking lots or allowed to turn around and leave the area

- 4. Additional Traffic Restrictions on Saturday, November 8, 2025:
 - Beginning at 8:00 AM, Virginia Street from Cross Street to Grace Street;
 Rappahannock Avenue from Marston Avenue to Virginia Street; and all of Prince
 George Street shall be closed to vehicular traffic, except law enforcement and fire
 and rescue vehicles.
 - Motor vehicles located within the corporate limits of the Town of Urbanna shall not be permitted to leave town until approximately 8:00 PM, or earlier as deemed appropriate by law enforcement.
- 5. Regulation of Golf Carts:

The 68th Annual Urbanna Oyster Festival kicks off on **Friday**, **November 7**th. **EXPECT STREET CLOSURES**, **PARKING RESTRICTIONS**, **AND CHANGES TO TRAFFIC PATTERNS**.

Here's what you need to know:

- **Parking**: Restrictions will be in effect from 2 AM Friday until late Saturday night. Several streets in town will be designated as No Parking zones, with towing enforced.
 - No parking on Urbanna Road, Watling St, Cross St, Prince George St, Virginia St, Marston Ave, and more.
 - Tow-away zones will be enforced throughout the festival area.
 - Streets may reopen for parking earlier on Saturday based on cleanup progress.

Road Closures:

- **Friday**, **Nov 7th**: Roads into town close at 5 PM (west side) and 6 PM (east side) for the Fireman's Parade.
- Saturday, Nov 8th: Road closures begin by 9 AM and will last until 8 PM or later.
- Access will be limited to emergency vehicles during these closures.

Parades:

- Friday, 7 PM Fireman's Parade
- Saturday, 2 PM Oyster Festival Parade

TOWN OF URBANNA 2025 OYSTER FESTIVAL STREET CLOSURES AND PARKING RESTRICTIONS

The Virginia Department of Transportation has approved the following 2025 Urbanna Oyster Festival Street Closures, Traffic Restrictions, and No Parking Zones pursuant to Resolutions 2025-016 and 2025-017 of the Urbanna Town Council:

Parking Restrictions

Parking restrictions will be in effect within the corporate limits of the Town of Urbanna between 2 a.m., Friday, November 7, 2025 and 11 p.m., Saturday, November 8, 2025 in order to ensure pedestrian safety, safe movement of police, fire, and rescue vehicles, and safe parade operations. Certain streets may be opened for parking earlier than 11 p.m. Saturday depending on the progress of cleanup crews.

No Parking areas will be designated as Tow Away Zones and towing will be at the owner's expense. The no parking-tow away zones for both sides of the streets in Urbanna include:

Urbanna Rd from the bridge to the Watling St intersection. Watling St from its intersection with Urbanna Rd at the traffic triangle to Cross St. Cross St from its intersection with Watling St all the way past the Marston Ave intersection. Prince George St from Cross St to Virginia St. Virginia St east from Waverly Rd to Oyster Rd. Marston Ave from Cross St to Rappahannock Ave. Rappahannock Ave south from the Marston Ave intersection to Virginia St. Marston Ave east from Cross St to first house on each side of street. Bonner St west from Rappahannock Ave to Linden Ave. Grace Ave from Bonner St to Virginia St. Park St from Rappahannock Ave to Linden Ave. Upton Ln by the Post Office, Hilliard St, Rappahannock Ave, Cross St, Oyster Rd, Prince George St and Kent St in their entirety.

Urbanna Street Restrictions

Other Restrictions: On Friday, November 7, and Saturday, November 8, 2025, law enforcement authorities may close selected streets to routine traffic as crowd and public safety actions dictate.

Town Entrance Restrictions

Friday, November 7, 2025, vehicular traffic entering or leaving the Town will be prohibited beginning at 5 p.m. on the west side (Route 602) in the vicinity of Lord Mott Road and beginning at 6 p.m. on the east side (Route 227) in the vicinity of Rosegill for the Fireman's Parade. These Routes will be closed to all traffic attempting to enter the Town of Urbanna except to facilitate the movement of police and emergency vehicles. The Town of Urbanna will remain closed until 9 p.m. or later depending on pedestrian traffic.

Saturday, November 8, 2025, 9 a.m. or earlier if deemed necessary by law enforcement authorities, State Route 227 (Urbanna Road) will be closed in the vicinity of the Molly's Way, and State Route 602 (Virginia Street) will be closed in the vicinity of Red Hill Drive. These Routes will be closed to all traffic attempting to

enter the Town of Urbanna except to facilitate the movement of police and emergency vehicles. The Town of Urbanna will remain closed until 8 p.m. or later depending on pedestrian traffic. At any time, law enforcement authorities may temporarily close the Town to routine traffic as crowd and public safety actions dictate.

Parade Routes and Times

The Friday, November 7, 2025, Fireman's Parade will begin at 7 p.m. and commence east on Virginia Street from the area of the Urbanna Professional Center, left on Grace Street, right on Bonner Street, left on Rappahannock Avenue, right on Marston Avenue, right on Cross Street, right on Virginia Street to a disband area where the parade began. The Saturday, November 8, 2025, Oyster Festival Parade will begin at 2 p.m. and will commence east from the staging and formation area at the Waverly Commons Office Building on Virginia Street, left on Grace Street, right on Bonner Street, left on Rappahannock Avenue, right on Marston Avenue, right on Cross Street, right on Prince George Street, left on Virginia Street to the disband area where the parade began.

- A. Major "No Parking Tow Away Zones": Between 2:00 AM Friday, November 7, 2025, and 11:00 PM Saturday, November 8, 2025, the following streets within the corporate boundaries of the Town of Urbanna shall be designated as "No Parking Tow Away Zones" and shall be prominently marked:

- Urbanna Road (State Route 227): From the Urbanna Bridge to the Watling Street
 (State Route 227 and State Route T1015) intersection, both sides of the street.
- 27 2. **Watling Street (State Route 227):** From its intersection with Urbanna Road (State Route 227) at the traffic triangle to Cross Street (State Route 227), both sides of the street.
- 30 3. **Cross Street (State Route 227 and State Route T1005):** From its intersection with Watling Street (State Route 227) past the Marston Avenue (State Route T1006) intersection, both sides of the street.
- 4. Prince George Street (State Route T1003): From Cross Street (State Route 227) to
 Virginia Street (State Route 227), both sides of the street.
- 5. **Virginia Street (State Route 227):** East from Waverly Road (State Route 1010) to Oyster Road (T1002) on the waterfront, both sides of the street.
- Marston Avenue (State Route T1006): From Cross Street (State Route T1005) to
 Rappahannock Avenue (State Route T1001), both sides of the street.
- 7. **Rappahannock Avenue (State Route T1001):** South from the Marston Avenue (State Route T1006) intersection to Virginia Street (State Route 227), both sides of the street.
- 42 8. **Bonner Street (State Route T1020):** West from Rappahannock Avenue (State Route T1001) to Linden Avenue (State Route T1021), both sides of the street.
- Grace Avenue (State Route 1010): From Bonner Street (State Route T1020) to
 Virginia Street (State Route 227), both sides of the street.
- 46 10. Park Street (State Route T1019): From Rappahannock Avenue (State Route T1001)
 47 to Linden Avenue (State Route T1021), both sides of the street.
- Upton Lane (State Route T1017): In its entirety, both sides of the street.
 Post Office patron 10-minute parking will be authorized on Friday until the road is
 closed by the Sheriff.

Fiscal Impact: \$1,659

c. Water Tower Logo Painting Options

Background: Earlier consideration of this topic resulted in a decision to not move forward with the application of a logo; to include, but not necessarily limited to, Oyster Shells, Urbanna, some reference to the Urbanna Oyster Festival, or a combination, given the cost. For that reason, the cost for this project was not budgeted for FY 25-26. Reconsideration has been requested and the Finance Committee has a meeting scheduled to discuss the matter.

Two basic design options are attached with cost proposals. Those proposals being open oyster shells and a reference to the Urbanna Oyster Festival. Simply stating "Urbanna" with or without shells would likely cost between the offered \$10,170 and \$15,255, a specific proposal has been requested.

If undertaken, the work should be done in concert with painting the exterior of the tank which can be done between Labor Day and October 1, 2025 to hold down costs of restaging for painting jus the logo. Again, a specific proposal has been requested. Painting can be delayed until sometime after April 1, 2026, but before Memorial Day weekend. Weather is a primary factor. Regardless of when undertaken, the tank must be drained during the painting for two weeks. This may very well require well six and perhaps five to pump continuously to meet demand. Thus, the dates proposed are to avoid heavy seasonal demands.

USG, which holds the tank maintenance contract, has indicated they can delay full payment or spread the payment out across budget years, but no absolute terms have been offered or discussed.

Staff believes that some of the significant trees that block the view of the tank are on town property; but this determination is made without an accurate survey which is an absolute necessity before any tree removal is undertaken.

Fiscal Impact: Between \$10,170 and \$15,255 for logo with surveying and tree removal to be determined.

Staff Recommendation: Decide whether to pursue the logo or not, and then, if so, which design.

Council Action Requested: Yes.

Exhibit B - Terms and Conditions

A. GENERAL TERMS AND CONDITIONS

The Terms and Conditions (the "Terms") of this Proposal govern the sale of services (the "Services") by Utility Service Co., Inc. (which for purposes herein shall include its affiliates) to the Customer. All other terms or variations to these Terms are excluded unless agreed explicitly in writing by a numbered amendment to this Proposal executed by Utility Service Co., Inc. and the Customer. Execution of the Proposal by the Customer, whether in writing, on the Internet, by electronic signature, or by e-mail transmission of a signed Proposal shall mean acceptance that these Terms are deemed incorporated into the Proposal and shall form the contract between the Customer and Utility Service Co., Inc. These Terms shall supersede all prior terms, understandings or Proposals between the Customer and Utility Service Co., Inc. If any part of the Terms should be found to be invalid or unenforceable by a court or other competent authority, then the remainder of the Terms shall not be affected. Any notice to be given with respect to these Terms by either of the Parties shall be in writing. Notices to the Customer shall be sent to the Customer's address on the Proposal, and any notices to Utility Service Co., Inc., including notice of warranty claims by the Customer, shall be sent to: Utility Service Co., Inc., ATTN: Customer Service Department, 535 General Courtney Hodges Boulevard, Post Office Box 1350, Perry, Georgia 31069.

This Proposal has been issued based on the information provided by the Customer and on information currently available to Utility Service Co., Inc. at the time of Proposal issuance. Any changes or discrepancies in site conditions, concealed conditions where the Services will be performed, changes in environmental, health, and safety regulations or conditions, changes in Customer's financial standing, Customer's requirements, or any other relevant change or discrepancy in the factual basis upon which this Proposal was created may lead to changes in the offering, including but not limited to, changes in pricing, warranties, quoted scope of work, and/or terms and conditions. Unless stated otherwise in the Proposal, performance and/or payment bonds are not included in the price. These bonds can be purchased on request but will be at an additional cost.

B. PRICES, PAYMENT TERMS, COMMITMENT OF CUSTOMER, CREDIT REPORTING AND TAXES

Prices, which are expressed in US Dollars, are only valid for the period stated in the Proposal. If not stated, the validity period is ninety (90) days. Unless otherwise stated in the Proposal, the full price shall be due and payable upon completion of the Services, which may or may not include the installation of Equipment. All of Utility Service Co., Inc.'s invoices are due and payable upon receipt. If any payment is not made by the Customer within sixty (60) calendar days following the date of the invoice, Utility Service Co., Inc. reserves the right to charge a late payment charge of one and one-half percent (1.5%) per month of the outstanding past due balance. Any failure by Customer to make timely payment of any obligation under this Proposal shall be deemed a breach. Upon your request, we will inform you of the name and address of the reporting agency from which we received such a report, if any. The price listed in the Proposal excludes all taxes unless specifically stated otherwise in the Proposal. The Customer is responsible for payment of all applicable taxes, however designated or incurred in connection with the transactions under this Proposal, and agrees to reimburse Utility Service Co., Inc. for any taxes paid on Customer's behalf.

C. DELIVERY OF SERVICES AND INSTALLATION OF EQUIPMENT

K. SATISFACTION OF WARRANTY CLAIM
